To ensure your bridal services are completed on time, the following conditions must be met.

ALL bridal attendants are required to:

- Be at the location on time.
- Have clean, dry hair, if hair services are being performed.
- Have makeup-free skin, if makeup is to be applied.

We may not be able to perform services for a bridal member who is late. We have contracted a specific amount of time with your party and may have other obligations elsewhere throughout the day. A \$25.00 fee will be charged when a bridal party arrives late. We will not be held responsible to complete all bridal members if a party is more than 15 minutes late. Again, we may have other obligations elsewhere and we are aware the bride may have scheduled photo obligations as well.

# Payments

A deposit of \$100 is required to hold the date of your wedding day. The deposit will be applied to the total amount owed for services. This will be refunded if we receive a 60-day cancellation notice.

A travel fee will be applied to any out of salon services. For locations within a 30-minute drive the travel fee is \$50 per stylist. For more distant locations, call us.

Full payment is required on the day the final services are performed. We request this payment be made in one payment from the bride. It becomes confusing when several people transfer money on the day of the wedding.

Cancellations must be received 30 days prior to the date of scheduled services to receive a 50% refund. No refunds will be given for any services cancelled less than 30 days notice as it is likely we have refused the opportunity to contract another bridal party.

We will not be held liable for any claims, losses, injuries or damages incurred that may occur as a result of negligent or willful misconduct from a bridal member or a bridal guest who is present in the salon or on location.
